**Running Order and Class Information**

***Fun Fur Paws – Mt. Vernon, WA***

**I-5 North/South:** Take Exit #218 (Starbird Rd) and East (Southbound turn left, Northbound turn right). Continue East to the 4-way stop at Bulson Rd and turn left. Follow Bulson Rd. to the intersection with Tyee Rd (0.7 mi). Turn left and then after a short distance, turn right onto Stargate Place (look for the sign for Fun Fur Paws). Follow the road to the arena and parking.

**Height Order & Schedule:** See chart below

**Height Cards:** If you have not been measured or indicated that you need a height card, you must be measured before you run. We are scheduled to have an official measurer at the show.

**Judging Start Time:** Friday 10:00 AM – first dog on line. Weekend 8:30 AM – first dog on line.

**Move-ups:** The deadline for move-ups is Monday Sept. 4 at 6PM. Moveups must be received in writing or email by that deadline. Day-to-Day move-ups are being accepted for Saturday & Sunday.

**Setup & Crating:** **Crate setup is not available in the arena until Friday morning as the arena is used for classes on Thursday night.** Crate space inside the arena is at a premium. There is crating in the stalls. Please note that these stalls must be shared by other exhibitors and their dogs. Stall doors must be left open at all times. Pop-ups may be set up on the grassy areas outside the arena (but not the new grass on the fenced agility fields please.

**Workers:** We are using the white board for workers. Please help out where you can ☺. We'll make special arrangements for workers to get their walks and runs. Let us know if you need to get a walkthrough and we'll make it happen.
