From I-5 Southbound Take exit number 165A towards James St. Stay straight to go onto 6th Ave. Turn right onto Columbia St.. Turn left onto 2nd Ave. Turn slight right onto 4th Ave S. Turn right onto Edgar Martinez Dr. S. Turn right onto 1st Ave. S. Turn right onto S Royal Brougham Way. Go up the ramp into the parking garage.

From I-5 Northbound: Take exit number 164B. Turn right onto Edgar Martinez Dr. S. Turn right onto 1st Ave. S. Turn right onto Royal Brougham Way. Go up the ramp into the parking garage.

From Ferry Terminal: Exit to the right (south) from the terminal onto Alaskan Way. Turn left on Royal Brougham Ave. Go up the ramp into the parking garage.

- Height Order:** All Classes: Saturday - Tall to Small, Sunday - Small to Tall
- Measurements:** We no longer need to see a height card, but you must indicate that you have one or that your dog needs to be measured. We will have a VMO on site for official measurements.
- Start Times:** First class starts at 9:00 AM (walkthrough at 8:30 AM) both days.
- Class Schedule:** Both Days – T2B, Exc Std, Open Std, Nov Std, Fast, Exc Jww, Open Jww, Nov Jww
- Walkthroughs:** There will be a single, timed, walkthrough for each class.

- Strollers:** There are NO STROLLERS allowed in the facility.
- Workers:** We are using the white board for workers. Workers will get coupons for each class worked based on class size that can be used for the entry raffle or cash.
- Friday Setup:** You can come in after 3PM on Friday to setup crates. There is generally no admission charge for Friday.
