Argus Ranch Facility for Dogs - 35612 212th Way SE, Auburn, WA 98092
www.argusranch.com - This trial will be held indoors at Argus Ranch.

Driving Directions

From North or South End

Take I-5, I-405, SR-167 to Highway 18 eastbound. Exit onto Auburn-Black Diamond Road eastbound. Turn RIGHT onto SE Green Valley Road (just past Neely Mansion). Follow for about 7.5 miles. Turn RIGHT onto 212th Way SE

Take First LEFT into Argus Ranch and follow drive straight ahead to Arena and signed parking.

From SR 169

Turn onto SE Green Valley Road (in front of the Boondocks Nursery). Go about four miles. Turn LEFT onto 212th Way SE. Go over the Cement Bridge. (Whitney Bridge) Take First LEFT into ARGUS RANCH and follow drive straight ahead to Arena and signed parking.

We may need to combine or alter walkthrus slightly due to COVID (like a walk/walk-run/run).

Directions: From Argus Ranch – turn left onto 212th Way SE and drive about 2 miles to the top of the hill to the ‘T’. Take a left and immediate right to stay on 212th Way SE and continue south for 3.2 miles to WA-164th/SE 436th St. Turn left for 2.0 miles and turn right on 244th Ave SE. Drive for 2 more miles to WA-410 (Enumclaw Buckley Rd) and turn right. Drive for 10.8 miles to the 166th Ave Exit and turn right onto Sumner Tapps Hwy E. Drive north for .3 miles and take a left onto 60th St. E Drive for .4 miles and the hospital is on the left.

Moveups: The deadline for moveups is March 12 at 6PM. Moveups must be received in writing or email by that deadline. Day-to-Day moveups are being accepted for Saturday and Sunday.

Setup and crating: There is **NO general crating allowed in the building. Popup tents and crating is allowed along the South grass areas on the knoll (not on the field). If using a popup or crate on the grass, please do NOT use mats or leave items overnight.**

RVs: All RV camping must be arranged with Argus Ranch. See argusranch.com for more info.

Food: Due to the required COVID restrictions by the state, we will NOT be providing any food, snacks or refreshments at the show. Please bring your own provisions 😊

Workers: Even given all the new “rules” and capacity limits, we STILL need your help putting on the show. If you can help out for a class – or a day – let us know. We’ll have a chief worker person coordinating thing and likely have the white boards setup like usual. THANKS!

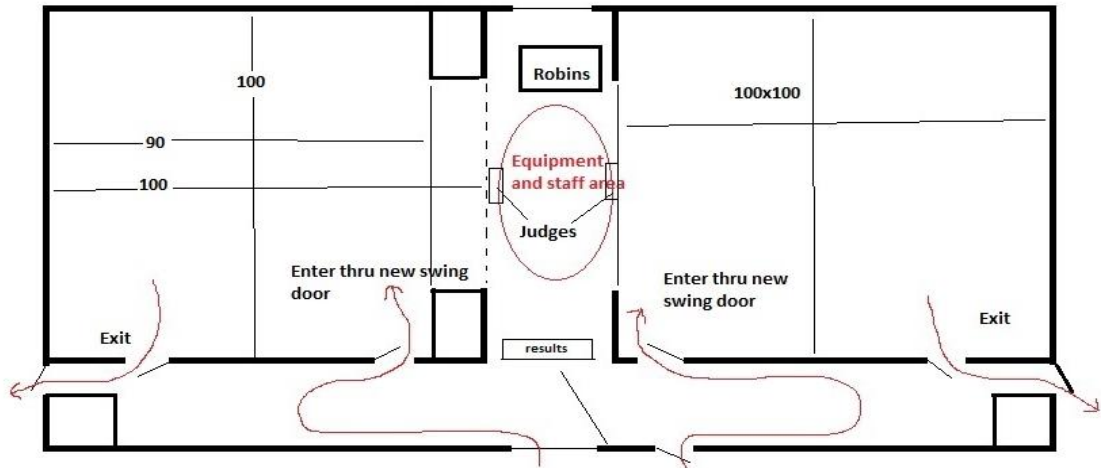
Measuring: A volunteer measuring official will be on site but measuring during these COVID times is different. If your dog can be left at the table with you at least 6’ away (safely!) and measured by a man in a mask, then we can potentially do the measure. Check with the score table for more info.

COVID Specific Information

Masks must be worn at all times in the building

Access Inside: Under Phase 2 and 3, we can allow more people in the building but still must maintain appropriate distancing. No chairs are allowed inside, and we are still limited to necessary participants. No outside spectators, guests, or vendors.

Building Flow: The diagram below shows the new COVID ring layout at Argus Ranch. The center aisle between the rings is for judges, course builders, and staff. The measuring table will also be in that area.



Course Maps: We will not be providing exhibitor copies of course maps. Maps will be made available on our website sometime after 6PM the previous night and posted on site. If you need a copy, please print one at home.

Leashes: We are planning on a leash runner using a “grabber”, but AKC rules now allow you to put your leash in your pocket, or tie it around your waist while you run. This allows only YOU to handle your leash. NOTE: if your dog grabs/tugs on the leash while running, the judge will signal an ‘E’. 😞

Results: Results will be posted outside the building and will be available on the same web page as the running order. We will also post results to the website as they are generated throughout the day so you can get them remotely.

COVID Waiver: **Due to the nature of our current COVID environment, a waiver will be required to be signed by all persons at the facility. Those with minors, please sign a waiver for your child.**



All persons must present a signed COVID waiver the first day they are at the show. You will then be given a wristband that is good for the entire trial. We are working on an electronic waiver system. If that is not finished in time, if you can't access the online version, or have other people with you, we will also accept paper copies. An email will be sent on Wednesday with more information.

Argus Ranch may have additional restrictions or rules. Please see www.argusranch.com for additional info.

Gate Check-in: We will have a normal gate steward with a paper gate sheet, but will also be using a new electronic gate checking and monitoring system available by any internet or wifi enabled device with a web browser.

The new system allows you to check-in, mark conflict or absent, see progress, and live scores as they are entered into the computer. Please check the status to make sure your runs are correct.

Maps will also be available on the same page (internet or local) sometime after 6PM.

The novel coronavirus, COVID -19, has been declared a worldwide pandemic by the World Health Organization (WHO). COVID-19 is EXTREMELY contagious and is believed to spread mainly from person to person contact. *As a result, federal, state & local governments and federal and state health agencies have instituted specific requirements for holding agricultural events (dog agility shows).*

The Club, R2Agility, and Argus Ranch LLC have put in place some new protocols & guidelines/preventative measures to help reduce the spread of COVID-19 at the Argus Ranch facility; however, the agencies handling the agility trial CANNOT guarantee that you will not become exposed to or infected with COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending this dog agility trial and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I understand that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including but not limited to agents, event secretary, event-giving club, AKC, the facility and any employees or volunteers of the aforementioned parties, and judge at the current event.

I voluntarily agree to assume all the foregoing risks and accept sole responsibility for any injury to myself (including but not limited to; personal injury, illness, permanent disability, or death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my attendance or participation in the current event. On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless the facility, event giving club, their members, directors, governors, agents, event secretary, any employees or volunteers of the aforementioned parties., and any AKC approved judge, of and from the claims, including all liabilities, claims actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the aforementioned parties, whether a COVID-19 infection occurs before, during, or after participation in this agility event.

By signing this waiver, I agree to the following:

I attest to the best of my knowledge that I DO NOT have COVID-19 at the time of attending the above referenced dog agility trial. I also attest that I have not knowingly been in contact with or exposed to any known carrier of COVID-19 within the past 21 days. I agree that I will follow all posted protocols, city, county, and state rules and requirements to reduce any exposure and possibility of contracting or spreading the virus during my attendance at this event.

I fully submit that the aforementioned entities related to this dog agility event are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, whether in attendance or not, during or after my dog related activities at this event.
