This trial will be held indoors at Argus Ranch.

Driving Directions

From North or South End

Take I-5, I-405, SR-167 to Highway 18 eastbound. Exit onto Auburn-Black Diamond Road eastbound. Turn RIGHT onto SE Green Valley Road (just past Neely Mansion). Follow for about 7.5 miles. Turn RIGHT onto 212th Way SE

Take First LEFT into Argus Ranch and follow drive straight ahead to Arena and signed parking.

From Hwy. 410 or WA 164 (Auburn-Enumclaw Hwy.)

Turn LEFT onto 244th Ave. SE (approximately one mile out of Buckley) Go STRAIGHT at Light on SE 436th Way/WA-164. Go STRAIGHT at Stop Sign SE 416th St. Go STRAIGHT at Stop Sign SE 400th St. Turn LEFT at Stop Sign onto SE 384th St. Turn RIGHT at Stop Sign 212th WAY SE. Turn RIGHT at ARGUS RANCH Sign (just before Bridge). Follow drive STRAIGHT ahead to Arena and signed parking.

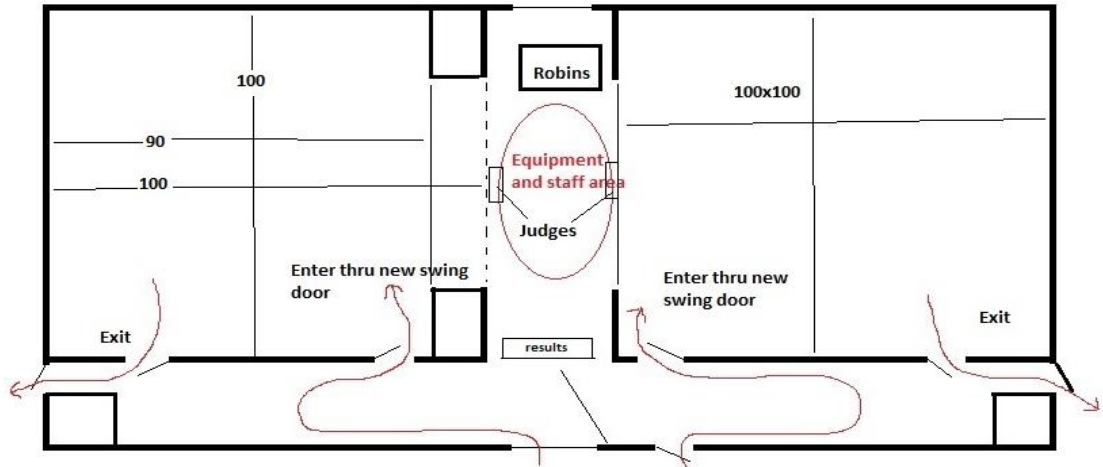
From SR-169

Turn onto SE Green Valley Road (in front of the Boondocks Nursery). Go about four miles. Turn LEFT onto 212th Way SE. Go over the Cement Bridge. (Whitney Bridge) Take First LEFT into ARGUS RANCH and follow drive straight ahead to Arena and signed parking.

Agility Trial Information

- Start Times:** Weekend 9:00 AM – Rings run at the same time. See the schedule below for details.

- Walkthroughs:** There will be a single walkthrough for each class with Exc Std and Jww split by height. See the charts below for the actual Split.
- Veterinarian:** 24-Hour Veterinarian: Sumner Vet Hospital, 16024 60th St. E, Sumner, WA 98390 253-863-2258
Directions: From Argus Ranch – turn left onto 212th Way SE and drive about 2 miles to the top of the hill to the 'T'. Take a left and immediate right to stay on 212th Way SE and continue south for 3.2 miles to WA-164th/SE 436th St. Turn left for 2.0 miles and turn right on 244th Ave SE. Drive for 2 more miles to WA-410 (Enumclaw Buckley Rd) and turn right. Drive for 10.8 miles to the 166th Ave Exit and turn right onto Sumner Tapps Hwy E. Drive north for .3 miles and take a left onto 60th St. E Drive for .4 miles and the hospital is on the left.
- Moveups:** The deadline for move-ups is Monday April 4th, at 6PM. Move-ups must be received in writing or email by that deadline. Day-to-day move-ups are being accepted for Saturday and Sunday.
- Food:** Due to the required COVID restrictions by the state, we will NOT be providing any food, snacks or refreshments at the show. Please bring your own provisions 😊
- Workers:** We are using the white board for workers. Please help out where you can 😊.
- Setup:** Setup will be available Friday morning. We don't get the facility until Friday.
- RVs:** All RV camping must be arranged with Argus Ranch.
- PHOTOS!** Nina Sage is scheduled to be at the show for your photo needs 😊

Building Flow: The diagram below shows the new COVID ring layout at Argus Ranch. The center aisle between the rings is for judges, course builders, and staff. The measuring table will also be in that area.



Course Maps: We will not be providing exhibitor copies of course maps. Maps will be made available on our website sometime after midnight the day of the show (www.r2agility.net). Please note this is a new AKC rule that judges can't give us maps until the day of the show (midnight at the earliest). If we're still awake, we'll post them. Otherwise they will be posted in the morning. If you need a paper copy, please print one at home if you can.

Leashes: AKC rules now allow you to put your leash in your pocket or tie it around your waist while you run. NOTE: if your dog grabs/tugs on the leash while running, the judge will signal an 'E'. ☹️

Results: Results will be posted outside the building and will be available on the same web page as the running order. We will also post results to the website as they are generated so you can get them remotely.

Gate Check-in: We will have a normal gate steward with a paper gate sheet but will also be using an electronic gate checking and monitoring system available by any internet or wifi enabled device with a web browser.

Maps will also be available on the same page (internet or local) that morning by 7 AM (ish).
