

# Seattle Kennel Club Agility Course Test 2 – ACT2

This is a beginning level event designed to introduce and welcome beginning dogs and handlers to AKC agility. The ACT2 is open to dogs that have not earned any AKC agility titles. This event has been created to let these dogs and handlers show their beginning agility sequencing and performance skills. In addition to running the courses, exhibitors will learn what to do at an agility trial and other information they would need when they are ready for a regular trial. There are 2 runs, or rounds. Any dog that passes both rounds earns an ACT2 title from AKC. Dogs must be 15 months or older to be able to enter. They do NOT need to be AKC registered at the time of the test. If the owner wishes to get a title certificate from AKC they will need to register their dog. Mixed breeds are welcome to enter.

## Agility Course Test 2 - ACT2

The ACT2 requires more skills than the ACT1. Course consists of 11 to 13 obstacles. These include an A-Frame, teeter, double jump, tire jump, bar jumps, table, tunnels and 6 weave poles. A dog walk is allowed in the ACT2. It is open to dogs that have no titles in the regular agility rings. Dogs with an ACT1 title may run in this test. An ACT1 title is not required to participate in the ACT2. Jump height divisions are 4, 8, 12, 16, 20, or 24 inches. Dogs may be entered in any one of the heights. A height card is not required. There are no preferred or regular heights. To qualify, entire course must be completed within 70 seconds. There can be no dropped bars or missed contacts. Each obstacle must be completed. No more than 3 wrong courses are allowed.

ACT2 will run after the Jumpers ring in the regular trial is finished, and the new course has been built. Approximate time would be 3pm. That is dependent on the number of entries in the regular trial. There will be a briefing and walk through. Pre-entry is preferred, but some day of test entries will be accepted until 2pm. Day of test entries cost \$5 more than pre-entry. Remember that there will be a regular agility trial running at when you arrive. There will be 2 runs. If both are passed, dog will earn the ACT2 title.

Pre-entry cost is \$15 per run. Juniors have a lower fee - \$12 per run. Day of Test entries cost \$20 per run. Juniors are \$17 per run.

In consideration of the acceptance of this entry and of the holding of and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. #### INSTRUCTIONS

Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. AKC Canine Partners™ applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the AKC Canine Partners™ program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
