Follow Bulson Rd. to the intersection with Tyee Rd (0.7 mi). Turn left and then after a short distance, turn right onto Stargate Place (look for the sign for Fun Fur Paws). Follow the road to the arena and parking.


<u>Pull-in parking</u> around the building ONLY. Do NOT back in to park around the building. If you do, you will be required to re-park.
