This trial will be held indoors on artificial turf.

Driving Directions

From North or South End

Take I-5, I-405, SR-167 to Highway 18 eastbound. Exit onto Auburn-Black Diamond Road eastbound. Turn RIGHT onto SE Green Valley Road (just past Neely Mansion). Follow for about 7.5 miles. Turn RIGHT onto 212th Way SE
Take First LEFT into Argus Ranch and follow drive straight ahead to Arena and signed parking.

From Hwy. 410 or WA 164 (Auburn-Enumclaw Hwy.)

Turn LEFT onto 244th Ave. SE (approximately one mile out of Buckley) Go STRAIGHT at Light on SE 436th Way/WA-164. Go STRAIGHT at Stop Sign SE 416th St. Go STRAIGHT at Stop Sign SE 400th St. Turn LEFT at Stop Sign onto SE 384th St. Turn RIGHT at Stop Sign 212th WAY SE. Turn RIGHT at ARGUS RANCH Sign (just before Bridge). Follow drive STRAIGHT ahead to Arena and signed parking.

From SR-169

Turn onto SE Green Valley Road (in front of the Boondocks Nursery). Go about four miles. Turn LEFT onto 212th Way SE. Go over the Cement Bridge. (Whitney Bridge) Take First LEFT into ARGUS RANCH and follow drive straight ahead to Arena and signed parking.

- Walkthroughs:** There will be a single walkthrough for each class except Exc Std and Jww split by height. See the charts below for the actual Split.
- Veterinarian:** 24-Hour Veterinarian: Sumner Vet Hospital, 16024 60th St. E, Sumner, WA 98390 253-863-2258
Directions: From Argus Ranch – turn left onto 212th Way SE and drive about 2 miles to the top of the hill to the ‘T’. Take a left and immediate right to stay on 212th Way SE and continue south for 3.2 miles to WA-164th/SE 436th St. Turn left for 2.0 miles and turn right on 244th Ave SE. Drive for 2 more miles to WA-410 (Enumclaw Buckley Rd) and turn right. Drive for 10.8 miles to the 166th Ave Exit and turn right onto Sumner Tapps Hwy E. Drive north for .3 miles and take a left onto 60th St. E Drive for .4 miles and the hospital is on the left.
- Moveups:** The deadline for move-ups is Monday Oct. 27th, at 6PM. Move-ups must be received in writing or email by that deadline. Day-to-day move-ups are being accepted for Saturday and Sunday.
- Food:** The club will not be providing any food, snacks or refreshments at the show. Please bring your own provisions 😊
- Workers:** We are using the white board for workers. Please help out where you can ☺.
- Setup:** Setup will be available Saturday morning. We don’t get the facility until Saturday.
- RVs:** All RV camping must be arranged with Run Wild.

- Course Maps:** We will not be providing general paper copies of course maps. Maps will be made available on our website – www.r2agility.net sometime after **midnight**. **Judges are not allowed to send us maps until after midnight** and we will make every effort to email/post them by 7:30 AM. Maps will be posted at a couple of places around the arena.
- Gate Check-in:** We will have a normal gate steward with a paper gate sheet but will also be using an electronic gate checking and monitoring system available by any internet or Wi-Fi enabled device with a web browser.
- The system allows you to check-in, mark conflict or absent, see progress, and live scores as they are entered into the computer. Please check the status to make sure your runs are correct.
- Maps will also be available on the same page (internet or local) sometime after 7:30 AM.
- Results:** Results will be posted in the arena and will be available on the same web page as the running order.
